Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Parents fill out a yearly LCAP survey. In addition, we have worked with the Special Education Department to engage parents of students with IEPs that could benefit from summer school services. In our weekly meeting with the ELD teacher, the interventionist, Special Education Director, and Executive Director we have met weekly to discuss student growth and identify student needs for services. We use the LCAP survey to capture faculty and staff input. In our weekly faculty meeting we also engage teachers about summer programming and after school tutoring.

A description of how students will be identified and the needs of students will be assessed.

We have a strong MTSS in place for literacy using the Science of Reading. We use the Houghton Mifflin universal screener for ELA and MATH. In addition, we use the QPS (quick phonics survey) to see how our students are progressing in their foundational reading skills. We also work with individual teachers and the interventionist to identify students that need added support. Student progress is

discussed weekly in the Student Success Meetings with the Director of Special Education, Director of Intervention, ELD teacher and Director of the school.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

We will send out an announcement via parent square and/or call parents to let them know of the supplemental instruction and support for summer and after school. Morning and after school care have been a constant in our school for years and after school tutoring has been in place for two years, so it's become part of our culture at Woodland Star. When a student does not take advantage of an opportunity, but the school feels there is a need, their teacher or the interventionist will reach out to the parent and invite them to join tutoring. We also discuss their progress during the SST process.

A description of the LEA's plan to provide supplemental instruction and support.

During the normal school year we offer a 10 hour and 10-minute day that runs from 7:00 am until 5:10. One hour of early care and two hours of aftercare. Additionally, we have transitioned from a half to full day kindergarten. The aftercare program is growing in its offering and will include many enrichment opportunities such as music, art, sports, and chess club. We have a robust after school tutoring program for both homework support and tutoring in math and literacy skills. Programming is available for five, nine-hour days during Winter and February breaks. Our summer program will run for nine hours, five day weeks for four weeks. There will enrichment activities in the arts, music, and sports, which will support SEL for all students involved. In addition, we will run an intervention program for six hours a day to support identified IEP, intervention students, and ELL students. We will also have ELD support for newcomers. Students will spend part of the day in structured intervention and the other part in enrichment classes.

Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.

- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students’ college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students’ social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
